### Qualifying

Five years or more after the jurisdiction of the Juvenile Court has terminated as to the person, or five years since the Juvenile was cited to appear before a Probation Officer or Law Enforcement Agent or at any time after the person has reached the age of 18, the person may petition the Court for the Sealing of the Records relating to the person's case. 781(a)

The person must not have been convicted of any Felony or Misdemeanor involving Moral Turpitude and that rehabilitation has been attained to the satisfaction of the Court. (781(a)

Convictions do qualify for Sealing under 781.

### Court Ordered Sealing

The Court shall order all records, papers and exhibits in the person's case in the custody of the Juvenile Court Sealed, including the Juvenile Court record, minute book entries, and entries on docket. 781(a)

The Court shall order Sealed, any other records relating to the case in the custody of the other agencies and officials as named in the order. 781(a)

#### 290 PC Registration

In any case in which a ward of the Juvenile Court is subject to the registration requirements set forth in Section 290 of the Penal Code, a Court, in ordering the Sealing of the Juvenile records of the person, also shall provide in the order that the person is relieved from the registration requirement and for the destruction of all registration information in the custody of the Department of Justice and other agencies and officials. 781(a)

#### Never Occurred

Once the Court has ordered the person's records Sealed, the proceedings in the case shall be deemed never to have occurred, and the person may properly reply accordingly to any inquiry about the events, the records of which are ordered Sealed. 781(a)

#### Civil Suit

In any action or proceeding based upon defamation, a Court may order Sealed records to be opened and admitted into evidence. 781(b)

The records shall be confidential and be available for inspection only by the Court, Jury, Parties, and Counsel for the Parties, and any other person authorized by the Court to inspect them. 781(b)

Upon Judgment in the action, the Court shall order the records Sealed. 781(b)

## LAW ENFORCEMENT AGENCIES RESPONSIBILITY

#### ❖ Notification

The Law Enforcement Agency receiving a Court ordered Sealing of Juvenile Records under 781, need only notify the Court of their compliance. 781(a)

Law Enforcement Agencies <u>DO NOT NEED</u> to notify any other agency or the Department of Justice of the record Sealing.
